

INVITATION FOR BIDS

1. Project Director GSC FESCO Faisalabad invites sealed bids on **percentage basis (Above / below) on estimated amount**, under Single Stage-Single Envelope bidding procedure, from eligible firms under **National Competitive Bidding (NCB)** basis in accordance with Provisions of PPRA Rules.

ELIGIBILITY

2. The Bidders meeting the following requirements will be eligible for participation in the bidding.
 - a. Written request accompanied with attested copies of.
 - b. Pakistan Engineering Council Certificate renewed for the **year 2024-25** with Category having Specialization Code as mentioned against above must be provided.
 - c. Identity Card of Contractor / Managing Partner / Director of the firm.
 - d. Bidding documents will be issued only to the owner / Managing Partner / Director of the firm.
 - e. The bidder must have completed at least two contracts of same nature along-with its completion successfully as main contractor within Ten years awarded by **WAPDA / NTDC / DISCOs**. The consolidated value of these contracts **must be more than** 40% of the **estimated / B.O.Q Cost**.
 - f. The contractor will submit separate application for issuance of each tender with relevant documents.
3. **The bidder shall be in the active tax payer list (ATL), and will provide** income Tax Returns for last three years.
4. The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
5. The bidder should have an **Average Annual Turnover *half of the amount*** mentioned against this work during last three years certified from audited financial statement.
6. Bidder shall demonstrate **Cash or Cash Equivalents *equal to 10% of contract value*** and current contract commitments. In this regard bidder shall provide the bank statements of last one year.
7. Eligible Bidders may obtain any information regarding bidding, from the Office of **Project Director (GSC) FESCO, Faisalabad up-to 21.07.2025**. A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee **Rs.5000/- (Five Thousand Rupees)** from the same office.

8. All bids must be accompanied by a Bid Security amounting to **5% on BOQ amount** each in favor of **Project Director GSC FESCO Faisalabad** of any scheduled bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
9. The bids will be opened at the office of **Project Director GSC FESCO Faisalabad** in the presence of bidders / bidder's authorized representatives who choose to attend the tender.
10. Tender rates and amounts should be filled in figures as well as in words. Tender documents should be signed as per general directions given in the tender documents.
11. All the procurement will be done according to PPRA Rules-2004 amendment up-to 2022.
12. Conditional / Electronic Bid shall not be permitted.
13. The bids covering partial and incomplete work shall be rejected.
14. All the bids along-with relevant documents received without binding with tender book will not acceptable.
15. The bidder will submit two copies of his bidding documents i.e. one will be original and 2nd will be photocopy.
16. All the pages of tender will be marked as page No. and each page must be signed and stamped by the bidder.
17. A certificate will also be submitted with bid documents mentioning that “the tender documents consists of page No.1 to pages.
